5. Eligibility Criteria for Tenderer:

- a. Tenderer shall be a manufacturer of Hessian Cloth and Twine.
- b. Annual Turn Over shall not be less than Rs.10 crore in each of last three years.
- c. Annual Production of Hessian Cloth should not be less than 3000 bales and 50 MT of Hessian Twines.
- d. Must have registered under Goods & Services Tax Authority.
- e. Must have valid Manufacturing License issued by Director of Factories.
- f. Must have supplied Hessian cloth of value not less than Rs.3.00 crores in a single contract each in last two years (2024-25 & 2025-26). In case of supply of Hessian Twines the value of supply shall not be less than Rs.15 lakhs in a single contract each in last two years.
- g. Must not be under declaration of Ineligibility.
- h. Outside manufacturers who do not have any branch inside Odisha and have not made any transaction inside Odisha but are participating in the tender shall produce an affidavit to that effect.

7. Earnest Money Deposit (EMD):

Each tender shall be accompanied with a bank draft of **Rs. 10,00,000/-** (Rupees Ten Lakh Only) drawn on any Nationalized Bank payable at Bhubaneswar in favour of the **Assistant Chief Conservator of Forests (KL)** towards Earnest Money deposit or Bid Security Money (BSM). The EMD will be forfeited if the bidder withdraws its bid before opening of the tender or does not deposit security money within specified period in case the bidder's offer is accepted by the competent authority. In other cases, it will be refunded. The earnest money will not be accepted in any other form. The EMD amount of successful tenderer will be adjusted against the Security Deposit.

11. About Financial Bid:

In the financial bid, price shall be quoted separately for basic price, statutory taxes applicable thereon (Cess, CGST/SGST, and others if applicable) and transportation cost for each Bale of Hessian Cloth (Superior), comprising One Bale = 1828.8 meters and one MT = 1000 Kgs. in case of Hessian Twine. The cost of transportation shall include packing forwarding, insurance charges, loading, unloading, and transportation to the specified destinations, anywhere within Odisha. ***The financial Bid shall be valid for a minimum of 90 days from the date of opening of the financial bid.***

12. Acceptance of Tender Document:

Tender document not submitted as per the terms and conditions spelt out herein shall be summarily rejected.

13. Opening of Technical Bid:

Bids will be opened on the scheduled date & time viz **10.04.2026 at 11.00 A.M.** in the office of **'First Party'** in the presence of the tenderers/their duly authorized persons. A Technical Committee constituted by the PCCF (KL) will examine and evaluate the technical bids with the reference to the terms & conditions of the tender and recommend the qualifying bidders to participate in the financial bid.

14. Opening of Financial Bid:

The financial bids of the bidders qualifying in the technical evaluation shall be opened in presence of such bidders/their authorized persons on the scheduled date viz **10.04.2026 at 4.00 P.M.** by the Purchase Committee constituted by the Government. The final acceptance of the tenders will be decided by the competent authority whose decision will be final.

15. Security Deposit (SD):

The successful bidder shall deposit **Rs.25,00,000/-** (Rupees Twenty-Five Lakh Only) towards security deposit within seven days of communication of acceptance of his offer (bid) in the **Bank Account No. 32269698772 (State Bank of India, Fortune Towers Branch, IFSC Code. 2. PDI of the materials before dispatch shall be made by an authorized organization/surveyors or staff of Kendu Leaves wing as will be decided by the Principal Chief Conservator of Forests, (Kendu Leaves), Odisha and only the materials passed in PDI and duly stamped shall be dispatched. The cost of PDI would be borne by the O/o- the Principal Chief Conservator of Forests (KL), Odisha.

19. Payment Schedule:

The successful bidder may submit bills, division-wise, against delivery of materials made. Payment of 90% of the bill will be made by the **Principal Chief Conservator Forests (Kendu Leaves), Odisha** on satisfactory receipt of the materials according to the required specification and after due verification at different destinations. Balance 10% shall be paid within 90 days of completion of satisfactory supply of goods, after recovery of Govt. dues if any outstanding against the supplier for breach of any terms and conditions of the agreement in respect of the supply. All payments will be made through RTGS. **The TDS @ 2% and TDS on GST @ 2% on the Basic Value of the Total Amount will be deducted as per the IT Act and GST Act respectively.**

20. Rescission of Agreement:

In the event of failure to supply the materials as per supply schedule or for breach of any terms and conditions of the contract, the agreement will be rescinded by the **Principal Chief Conservator of Forests (KL), Odisha, Bhubaneswar**, who reserves the right to procure the required quantity from other sources. Excess cost, if any, incurred for the same and loss if any, sustained by the Government on this account shall be recovered from the Security Deposit and if that is insufficient, then the balance amount will be recovered as arrears of land revenue under Odisha Public Demand Recovery Act. 2. That, the materials duly passed in the Pre-Delivery Inspection (PDI) shall be properly packed for transit by the **Second Party** and dispatched at his risk and the **First Party** shall not be responsible for any loss or damage during transit till receipt of the consignment by the concerned Divisional Forest Officer, Kendu Leaves at specified destinations within the schedule time as mentioned under Clause-3.

8. That, any damage or deficiency observed at the receiving Centres (concerned (KL) Divisions) within 15 days of receipt of consignment shall be sorted out through joint verification within 30 days of delivery & the DFO (KL) concerned will be at liberty to take ex-party decision in case the **Second Party** fails to attend the Joint Verification. The differential amount or the claim on account of such deficiencies etc. will be recovered from the **Second Party** from his billed amount.

9. 11. **Terms of Payment:**

As per the terms notified in the tender document, the successful bidder is required to submit the bills division wise to the PCCF (KL) after satisfactory receipt of the goods according to the specification approved in the technical bid by the consignee DFO (KL) and the result of the PDI by the designated agencies.

On receipt of the above, 90% of the billed amount will be released to the **Second Party** by the **First Party**.
